

# Loan Agreement for MMU

This Loan Agreement ("Agreement") is entered into between Mission Community Services Society (MCSS) and the borrowing service provider ("Borrower") for the loan of the Mobile Medical Unit (MMU). This Agreement outlines the terms and conditions governing the loan of the unit.

### 3. Terms and Conditions

## • Use of the MMU:

- The Borrower shall use the MMU solely for the purpose of providing services to underserved communities or specific target populations as agreed upon with MCSS.
- The Borrower shall comply with all applicable laws, regulations, and standards governing the use, operation, and maintenance of the MMU.
- The Borrower shall not make any alterations or modifications to the unit without prior written consent from MCSS.
- **Condition and Maintenance:** The Borrower shall maintain the MMU in good condition and promptly report any damages or malfunctions to MCSS.
- **Insurance:** Only people who have been named on the insurance as driver may operate the mobile medical unit. All drivers must submit copies of their license and drivers abstract to MCSS for approval prior to driving the unit.
- **Indemnification:** The Borrower shall indemnify and hold MCSS harmless from any claims, damages, liabilities, or expenses arising from the Borrower's use or possession of the MMU.



#### Loan Return:

- o The Borrower shall return the MMU to MCSS in the same condition as it was received.
- The Borrower shall be responsible for any costs associated with the return of the unit, including transportation and logistics, unless otherwise agreed upon in writing.
- **4. Governing Law and Jurisdiction:** This Agreement shall be governed by and construed in accordance with the laws of British Columbia. Any disputes arising out of or in connection with this Agreement shall be subject to the exclusive jurisdiction of the courts of British Columbia.
- **5. Entire Agreement:** This Agreement constitutes the entire understanding between MCSS and the Borrower regarding the loan of the MMU and supersedes any prior discussions, agreements, or representations.
- **6. Amendments:** Any amendments or modifications to this Agreement shall be made in writing and require the mutual consent of both parties.
- **7. Execution:** This Agreement may be executed in counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same instrument.
